# MSD offers FREE Louisville Green soil amendment—reservations required

LOUISVILLE, KY–Louisville Green is an earth-friendly soil amendment ideal for land applications from farms to lawns, landscapes and gardens. The soil amendment is a byproduct of the wastewater treatment process at MSD's Morris Forman Water Quality Treatment Center.

MSD is now offering Louisville Green FREE to residents of Kentucky or Indiana. However, you must receive the bulk product with a minimum order of 15 tons and provide secure transport. In addition, Louisville Green cannot be re-sold or distributed as fertilizer without proper registration. If the end-user intends to re-sell the product, they must provide appropriate documentation to MSD.

MSD will respond to all emails with a pickup reservation date(s). The transport vehicle must not exceed 12-feet, 6-inches in height, and not allow any product leakage. In addition, individuals must comply with Louisville Green Best Management Practices, available at <a href="LouisvilleMSD.org/LouisvilleGreen">LouisvilleMSD.org/LouisvilleGreen</a> under "Laboratory Analysis" and "Louisville Green Transporation Document." Customers will also receive a paper copy of the transportation document upon arrival at the facility.
